

- Delays in the legislative implementation in the Member States
- Lack of information on the state of play of the legislative implementation
- Even if implemented, instruments are barely applied



- Delays in the legislative implementation in the Member States
 - **★** FD Freezing of assets
 - -> Timelimit: 02/08/2005
 - -> 23 Member States
 - **X** FD Financial penalties
 - -> Timelimit: 22/03/2007
 - -> 17 Member States
 - **X** FD Confiscation orders
 - -> Timelimit: 24/11/2008
 - -> 14 Member States

Current situation

- More instruments to come in near future:
 - **X** FD probation measures and alternative sanctions
 - -> Timelimit: 06/12/2011
 - ★ FD custodial sentences or measures involving deprivation of liberty
 - -> Timelimit: 05/12/2011
 - **X** FD European Evidence Warrant
 - -> Timelimit: 19/01/2011
 - -> To be noted that a new initiative on the European Investigation Order has been submitted



And more...

- **X** FD Judgements in absentia
- -> Timelimit: 28/03/2011
- ★ FD supervision measures as an alternative to provisional detention
- -> Timelimit: 01/12/2012


